# Old Harbor Scholarship Foundation, Inc. Youth Scholarship Application

## **APPLICATION PROCEDURES**

**YOUTH STUDENTS**: Youth students who are Alaska Natives and either a shareholder of Old Harbor Native Corporation or a descendant of Old Harbor Native Corporation are eligible for a scholarship from the Old Harbor Scholarship Foundation ("OHSF") in order to attend educational activities or field trips.

All youth students must submit a complete application with a completed descendants form if it is not currently on file for consideration of a scholarship. A youth student is eligible for a maximum of one scholarship per year up to a maximum of \$1,000.

Awards of scholarships to youth students will be made by the Old Harbor Scholarship Foundation Board and will be based on the funds available to the student's needs, the nature of the education activity or field trip, and the quality of the student's essay and application.

Recipients of any scholarship awarded by OHSF shall use the funds awarded solely for the purposes stated in the application and essay. Receipts of any scholarship awarded by OHSF that use the scholarship funds for any other purposes may be required by the IRS to pay taxes on those funds.

Scholarships awarded by OHSF will only be disbursed by OHSF directly to the organization that is organizing or operating the educational activity/field trip and/or to a vendor if the scholarship is to be used for travel, hotel expenses, etc. Scholarship funds will **not** be disbursed directly to the scholarship recipient or their family, unless receipts are provided with a w-9 form for reimbursement. Any funds not used will be returned to OHSF.
